RESTORE: HFHCR OPERATES THREE RESTORE RETAIL LOCATIONS, ACCEPTING DONATIONS OF NEW AND GENTLY USED FURNITURE, APPLIANCES, HOME GOODS, AND CONSTRUCTION TOOLS/MATERIALS. DONATED ITEMS ARE RESOLD TO THE PUBLIC AT SIGNIFICANTLY LESS THAN RETAIL PRICES. RESTORE OPERATIONS CONTRIBUTE FUNDING FOR HFHCR'S MISSION WHILE ALSO DIVERTING GOODS FROM LANDFILLS AND PROVIDING A LOWER-COST OPTION FOR COMMUNITY MEMBERS WITH LIMITED FINANCIAL RESOURCES. IN FY24, HFHCR'S RESTORE LOCATIONS PROCESSED 16,880 SALES TRANSACTIONS OF DONATED GOODS.

HOME CONSTRUCTION: HFHCR BUILDS AND REHABILITATES HOMES, PROVIDES CRITICAL HOME REPAIRS AND BUILDS ACCESSIBILITY RAMPS THROUGHOUT MICHIGAN'S CAPITAL REGION. PARTNERING WITH HUNDREDS OF VOLUNTEERS AND VARIOUS FINANCIAL SUPPORTERS, HFHCR CREATES HOMEOWNERSHIP OPPORTUNITIES WHILE ALSO MAINTAINING SAFE, HEALTHY, ACCESSIBLE HOMES FOR EXISTING HOMEOWNERS. THE RAMP PROGRAM IS ALSO OPEN TO RENTERS. HOMEOWNERSHIP IS ABOUT MORE THAN SHELTER; IT CONTRIBUTES TO MANY SOCIAL DETERMINANTS OF HEALTH. HFHCR HAS COMPLETED OVER 1,000 CONSTRUCTION PROJECTS THROUGHOUT INGHAM AND EATON COUNTIES IN MICHIGAN.

HOMEBUYER PARTNERS ATTEND VARIOUS CLASSES IN AREAS SUCH AS FINANCIAL HEALTH AND BASIC HOME REPAIR, WHILE ALSO INVESTING 200-400 HOURS OF THEIR OWN TIME (SWEAT EQUITY) HELPING TO BUILD THEIR HOMES AND THE HOMES OF OTHERS.
